## Rules & Information

1. **FEES:** Entry Fee \$20.00. Office Fee: \$10.00. All paperwork must be accompanied by payment (Total Fees: \$30.00).
2. **DEADLINE:** Completed application and fees in full must be post marked on or turned into the Lewiston Roundup Office no later than **August 20, 2022**. Any postmarked or received after August 20, 2022 will be subject to a **\$10.00 late fee**.
3. **AGE:** Open to barrel racers age 14 - 18 years of age as of January 1st, 2022. **Copy of birth certificate or government issued photo ID required and must be submitted with the application.**
4. **DRESS CODE:** Contestants must wear a long sleeved western shirt or blouse, and a western hat or approved helmet.
5. **CONTESTANT INSURANCE & LIABILITY:** All contestants and/or parent/guardian for contestants under the age of 18 must execute and return with the application the "Contestant Release and Proof of Insurance Form." Contestants must have liability and/or injury insurance acceptable to the Lewiston Roundup Association. Please note, contestants and/or parent/guardians of contestants under the age of 18 will need to attend the Check-In meeting in order to sign additional liability waivers (if applicable).
6. **AMATEUR STATUS:** All contestants must be of amateur status only. Professional standing will not be accepted. Professional status is defined as an individual in possession of a Women Professional Rodeo Association (WPRA) permit or card.
7. **FORMAT:** Tryouts: 6:29 p.m. Saturday, August 27<sup>th</sup>, 2022 (*Or immediately following the Lewiston Round up Classic Barrel Race if after 6:29 p.m.*). Contestants will make two runs. **\*New draw format: Random draw for first go and second go. Draw will be posted after check in is complete. The arena will be watered and big rake between first and second go.** The top eighteen contestants, based on lowest aggregate times on two runs, will advance to the Thursday, Friday and Saturday night performances.
  - a. Day and order of performance will be based on contestant draw to be conducted immediately after the Saturday tryouts. Fastest aggregate time will draw for performance first, slowest aggregate time will draw for performance last. Top 18 will be given the opportunity to trade performances as needed, following the draw.
8. **PAYOUT:** 100% of Entry Fees collected will be paid out jackpot style, based only on times run during the performances of the Lewiston Roundup. Placings will be paid as follows:

- a. Fastest time from the performances of the Lewiston Roundup will be declared Amateur Girls Barrel Racing Champion. First Place/Champion will also be awarded a trophy item at the discretion of the Lewiston Roundup Association.
  - b. All checks earned will be mailed to the address listed on the barrel racing application after the conclusion of the Lewiston Roundup.
  - c. Any awards will be mailed to the address listed on the barrel racing application after the conclusion of the Lewiston Roundup.
9. **PATTERN:** Barrels 1 & 2 will be 90 feet apart; Barrels 1 & 3 and Barrels 2 & 3 will be 105 feet apart, with a 60 foot score line. There will be a five-second penalty for each downed barrel. The Lewiston Roundup Association reserves the right to make any changes it deems appropriate in procedures, rules and course without notice.
10. **CHECK IN:** All contestants must check in at the Rodeo Secretary's office between **4:00 and 5:00 p.m. on Saturday, August 27<sup>th</sup>, 2022**. If all entries have checked in, the Lewiston Roundup Association may start the Race early at its discretion. For questions contact Travis 208-791-8989
11. A Health Certification from a Veterinarian is required for all out of state horses. A Coggins Test is required for states other than Idaho, Washington, and Oregon. The Lewiston Roundup Association suggests brand inspections also be readily available in case the Brand Inspector is on-site. Having paperwork within reach when coming through the participant's entrance would be appreciated.
